Notes from the Prez by Jim Dinkey

"Trick or Treat"— It's Not Just For Halloween

Whether it's software you bought from a bigname source or something you got for free from a no-name, you have to be alert when you install it so you **don't open yourself up to some ghoul or pirate or other attacker who wants more from you than you expected.** And those ghouls, pirates, etc., are always adding to their bag of tricks to use on you. It is a sad commentary on the ethics of some companies that they use this type of "software pushing". It is also a fact of life that most of us just press NEXT when doing installs—and the unscrupulous ones take advantage of this!

One of their tricks is to present you with a small box that they hope you'll ignore or miss, with an already-checked permission to allow their software to be inserted onto your computer. I wonder how many people who aren't paid to do so take the time to really read all the garbage presented when they're doing something as mundane as updating software. If you have accidentally installed some junkware, go to ADD/REMOVE and delete it; your computer will run faster without it and you'll have more "real estate" at the top of your browser. Also remove anything else that you are sure is no longer needed. If you don't recognize a program, put its name into GOOGLE and see if the program is merely left over from some other software.

Secunia is a program that will check for the latest updates for non-Microsoft software. You should probably run the program's scanner about every two weeks just to assure that your software is up-to-date.

Here are some examples of ghoulish tricks that are not treats.

Java

The **"Java Setup - Yahoo Toolbar"** has a check box labeled "Install the Yahoo Toolbar".

You need to keep your Java Runtime Environment (JRE) current, but doing so shouldn't be an invitation for the manufacturer to dump junk onto your computer and slow it even further.

Another Java updating trick is to display "Java Setup – MSN Toolbar" right at the top. If you're not careful, you'll miss unchecking the boxed line titled "Install the new MSN Toolbar". You don't need this junk slowing down your computer. Remember OVERHEAD!

Adobe

Adobe has a number of items that they want to install.

When you're trying to update Adobe Flash Player, Adobe—using some obscure logic will ask if you want the **"Free McAfee Security Scan"** (with the permission box already conveniently checked).

Adobe presents at least <u>two</u> items (the other choice is **"Free Google Toolbar"**). Each time you update, Adobe evidently picks out something else to push to you in hopes you will miss the required unchecking of the box.

I wonder how many products Adobe has lined up to push onto our computers!

Apple

Basically you need to have QuickTime on your computer to handle some animated downloads and other generally useful presentations. But what does this have to do with their pushing a window at you that says: **"Upgrade from Video Watcher to Video Maker"**, with the default that your next mouse click goes to "GoProNow"?

Microsoft

When updating Microsoft software, do not click on that little yellow shield that appears at the bottom right of your screen when Microsoft has made patches available. The reason is that if you do click on that shield, Microsoft will go ahead and install ALL updates that could be applied, whether you wanted those updates to happen or not, or even had marked them as "Do Not Install".

For example, IE8 is not yet ready for the big time as Microsoft is still patching it heavily. Thus I (and I hope you) have not permitted IE8 to be downloaded from Microsoft. But if you click on the yellow update indicator, you will not get the opportunity to block the installation of IE8 and you will have been out-foxed by Microsoft. It is fine to note that there are some updates for the Microsoft software, but **go to Windows Update by clicking on TOOLS in IE** to control the updating process yourself.

Enable DEP—Whether you're updating or not

And finally, one argument for going to IE8 is the presence, natively, of DEP (Data Execution Prevention).

It has been stated that IE7 has DEP turned OFF by default, but I found that was it not only turned ON in IE7, but that there was a program that was already being accepted by my computer via DEP. Officially, DEP has been turned on since SP2, so hopefully, you will only have to check that it is ON.

All you have to do to check or turn on DEP in IE7 is right-click on "My Computer", select "Properties" and "Advanced", and then "Performance" and "Setting". Then select "Data Execution Prevention" and you can then activate or find that DEP is already turned on – possibly by a Microsoft Download Patch. **No matter what, it is in your best interests to have DEP ON.** Since it's so easily done in IE7, there's no good reason to install IE8 to get it.

Product Report: My New ASUS 1005HA Netbook—by Robert White

In our July 2009 general meeting, Hank Skawinski recommended the ASUS 1000HE. The key distinguishing feature is a 6-cell battery instead of a 3-cell. There are several models in the series, the designation appears to be 100xHE, fill in your own 'x'. Other info about Hank's netbook, and the series:

- Hank bought a 10" ASUS 1000HE EEE-PC with the Atom processor.
- Photoshop would NOT run well.
- Battery life was 9 hours with the 6 cell battery.
- Has WiFi, wired network and bluetooth.
- Has good tactile keyboard and runs on 12 volts.
- Needs an external CD/DVD drive (USB powered).

I bought an ASUS Eee PC 1005HA at Micro Center. It has the 6-cell battery Hank recommended. With Linux running on an external HD, from which the machine will boot as Hank claimed, I have seen in excess of 5 hours **battery life.** I've not had a chance yet to run the battery from full charge to shutdown, so I don't yet know its full life. My measure is with the machine fully active and powering the external disk, so I suspect it is consistent with the mfr's 10-hour claim, which typically results from applying several power reduction techniques.

The only disappointment I have with the machine is that **the screen is only 600 pixels high,** so tool bars, etc. at the top of browsers and other apps eat a lot of screen height. It is otherwise an excellent light-duty long-duration machine, and I heartily recommend it to anyone for whom its capability is appropriate! When it's connected to an external 1440x900 display, it can simultaneously drive the display to full resolution and use its own display as a secondary monitor. Someone who needs a large screen for home use and a good traveling machine can get both simultaneously with this netbook and an external display.

General Meeting Notes 9 September 2009

<u>Crosstalk</u>

- The Microsoft updates from Patch Tuesday look good; you should install them at your earliest convenience. Do this first, using the Windows Updater in Windows Explorer or Internet Explorer unless you use the automatic update.
- Next, run **Secunia** (http://secunia.com/) to check for updates to other applications, and make any updates suggested. [N.B.- I use Secunia PSI, an application that installs on my computer and monitors my apps for updates. It checks periodically, and reminds me. Also, Secunia will send reminders if you sign up for them]
- Watch out for Orbit. (**Orbit Downloader** is a free social music, video and file downloader. Also it supports streaming media protocols including RTMP and can download music and ...) It's apparently a downloader that installs itself on your computer. It doesn't seem to be harmful, but it is no value added over the MS downloader, and may be a security issue in the future.
- Periodically run the

 MalwareBytes, to
 ensure trouble-free (at least from malware!)
 computing.

- Windows 7 is available as a 90-day free trial, by download only. There are a limited number available, so if you are a glutton for pain and frustration, go for it. Don't try it on any mission-critical hardware, though.
- John Sleeman will be coordinating the vinylto-CD program at Peterson's company, 26 September is latest proposed date; watch for more information. Cost will be \$6+tax per vinyl (33¹/₃, 45, or 78 rpm). Be sure record and sleeve are labeled with your ID (use those free return address labels).
- The slide scanner is now at Micro Center. Maury will send info how to qualify and sign up for use. Expect to attend a training session.
- Expect to replace the **motherboard battery** about every five years. If you don't, your computer date will not be correct, and other unpleasant things will happen. It would probably be good to make a record of your BIOS settings (a digital camera works, or just use pen and paper).

Notes on email and domains

- **Prodigy** (so long ago I've forgotten my email address)—It came with the service, I think it used a proprietary application. Also, transferred via modem no attachments, photos, etc.
- Lockheed Martin—Same address since they gave email addresses to employees, provided by LMCO and works via Microsoft Outlook and the Company Outlook Server. Can use Word to compose and read messages. Company policy does not allow for-

warding email automatically (i.e. when on vacation, etc.) and there is no Internet access to messages.

- Hutchings family domain, ct-sv.com provided service, so stan@ct-sv.com worked for a while, until we dropped the domain. We could use any of the standard SMTP programs, and I tried several, including Eudora, but still went back to OE.
- Earthlink—Was our ISP for a while. We tried to use our ct-sv address, but Earthlink would require a service upgrade at higher price. I was using Outlook Express with their server. This caused frequent problems due to connection via their DSL modem, configuration and uptime issues. Although you could supposedly access your account from the Internet, it was complicated and we had trouble doing it. When we switched to Comcast, we could not keep the addresses. A classic case for the need of a DOMAIN.
- **Gmail**—Was introduced and I opened an account so I could send and receive email from anywhere Internet was available. I also did not have to use Outlook Express to compose and receive email.

After getting used to the interface and Label instead of Folder concept, I grew to use it in preference to other systems. Unfortunately, Lockheed security forbade using gmail, hotmail, yahoo, and other Internet based systems. The work-around was to automatically forward incoming gmail messages to Imco; then answer the urgent ones from work.

The features of gmail caused me to prefer it to all others. I use filters to automatically categorize email based on senders. The new

- keyboard commands mean less mousing,
- the contacts are available at any time (unlike OE and other SMTP accounts), the
- choice of plain text or HTML formatting wysiwyg style,
 easy file attachment,
- autosave of drafts as you type, etc. have

Further, I am currently using 296 MB (4%) of my 7367 MB free quota, and see at most one or two spams per week.

When my family joined Comcast to get the broadband cable, we got a number of free email addresses, but I almost never use them. I would have to go back to Outlook Express. So I configure gmail to receive the Comcast email; and also allow me to send from gmail as if from the Comcast account.

- **Review of September meeting:** Les Laky and Stan Hutchings presented a good panel discussion on the advantages of having your own domain name. Maury has the slide presentation from Les Laky, Stan Hutchings' notes and a copy of the audio recording of the presentation. He will combine this material for a story on the website.

- Upcoming meetings: Speakers have been arranged for monthly meetings thru Feb 2010.

Website issues: Jim reported he was unable to find an article (October 2008 Prez Notes) when he did a search on SVUGA site for "SPAUG" and "630" but was able to find it with Google. (ed. After the meeting Maury reset the search sensitivity on the website and the search succeeded.) Film Scanner program: Maury reported that DISIG (SVCS) has purchased the Epson scanner and a computer. It is housed in the tech support area at Micro Center. DISIG will present seminars on proper use of the scanner and only those who attend the seminar will be eligible to use it. An automated reservation system is being set up on the SVUGA website and the scanner will be available during regular Micro Center store hours, except Saturdays and Sundays from 2PM to 4PM when they present their in-house clinics.

"Vinyl" record conversion: John Sleeman will oversee the program for members wanting to have their LP/45/78 records converted to CD. The event is scheduled for Sept 26th at Peterson's in Cupertino. Cost will be \$6 per vinyl record (2-side) plus tax. Details will be provided in an email and on the website.
