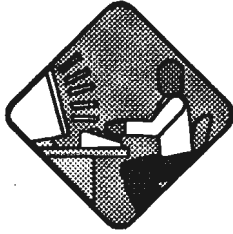

Technical Session by Power Quest

February 24

User Group Relations has the following two training seminars that they present to user groups. While these topics are quite technical in nature, we will present them in an easy to understand manner without getting too involved with lots of technical details. We will also make these materials available to user groups to present to their members. They include a set of training slides and a script.

Hard Drive Training Seminar .

What makes your hard drive work? This section looks at the physical makeup of your hard drive and how it works on your computer. We'll look at the recording surface of hard drives, how read/write heads store and retrieve data from your hard drive, and where your data is recorded on the disk surfaces. We'll also look briefly at the physical addressing techniques, so that you will understand what a cylinder, head, sector address means. Finally, We'll look at the timing elements (seek time, rotational delay time, and data transfer time) of your hard drive.

What are partitions on your hard drive? Once we learn how information is physically stored on your hard drive, we can start to learn how this information is logically organized. The highest level of organization is partitions. We will learn how partitions are created, the different types of partitions that you can have, and the limitations that each of these types have. We'll also look at how these partitions are linked together by the Master Boot Record and the Partition Tables.

How are files in a partition organized? The next step in understanding your hard drives is to identify the various operating systems and the files systems that they build in each partition. We will look at the commonest file system (the FAT) and try to understand how it organizes your files. After this section, you'll have a better understanding of your directories or folders, how files are stored, and what fragmentation means. We'll also look at some of the limitations (the cylinder problem, for example) of the FAT file system how FAT32 can solve those problems.

How are partitions assigned drive letters? Finally, we will look at how the operating systems assign

drive letters to each partition. We'll explore how letters are assigned when multiple operating systems are involved. To conclude, we'll recommend some approaches in organizing your partitions.

Backup/Recovery Training Seminar.

What backup approaches are available for your hard drive? This section will discuss the various ways you may lose files from your hard drive and what you can do to recover from each of these losses. There are two basically different types of backup utilities on the market. We will explore the strengths and weaknesses of each and give some hints as to when and how they should be used.

We will develop a sensible backup strategy to protect your hard drive information from any number of losses.

How to recover your files from loss? Having a current backup of your hard drive is a first line of defense against permanently lost files. We'll look at what it takes to recover your system depending on what type of backup you have and how current they are. We'll also look at what new technology exists to recover your files even if you don't have a current backup to fall back on.

Random Access

Summary from the January General Meeting

Q1. I had performance problems, so I reformatted my hard drive and tried to reload WIN95 from the CD ROM. The Recovery diskette will get the A: and C:\ drives but not the CD ROM drive where WIN95 is located. What now?

Feed Back 1. WIN95 in its setup for the Recovery diskette does not make a copy of the installed CD ROM driver. You have to make it a separate operation. WIN 98 does copy the CD ROM driver as well as the system files.

FB1. There is a detailed description of this procedure on the website, [http://www . everythingcomputers.com](http://www.everythingcomputers.com).

FB1. You need the generic DOS driver for the CD ROM. It could be copied off another computer onto the Recovery diskette. Then insert it in the A drive, turn power on, and continue with the WIN95 reinstallation. The CD ROM drive should be recognized, and load WIN95.

Q2. Any one having trouble loading TurboTax for WIN98?

FB2. Two people reported having trouble loading TurboTax from the cd ROM. Another had a State problem, it did not finish loading until the very end. General consensus was the CD ROM was corrupt. FB2. Be sure to have all other programs turned off - none running in the background.

Q3. In Word for Windows, I want to highlight a part of a paragraph near the bottom of the screen, and onto the next screen. The highlight flashes to the next several paragraphs, far beyond where I want to go. Then I have to back up and jockey while I get what I want. How to slow it down?

FB3. Super fine highlighting can be done placing the cursor at the start place, hold down the SHIFT key while using the arrow keys, or page up/down keys. Furthermore, holding the SHIFT and CNTRL keys down, the highlight goes to the start of the next word.

Q4. Does the shift click work for Excel; i.e. rows/columns?

FB4. First CLICK the left mouse button where you want highlighting to start, then move to the end and hold down the SHIFT key and Click the left mouse button again. The whole area in between is now highlighted. It works with most Microsoft products.

Helpful hint; One member reports that he found WIN98 loading is more stable using the following procedure. From Start, go to Run and type MSCONFIG. Here a System Configuration Utility screen that you to load device drivers and software as you desire. It allows one to Unselect the automatic loading of certain files at Start up. It gives a menu from which you can select which files will load; i.e., config.sys, autoexec.bat, system.ini, win.ini and startup. It will reboot the computer. I now have a really clean start up, and a lot better than using the control-alt-deletes to close troublesome programs.

Tips & Tricks

Recovering Drivers with Version Control Manager

Click on Start | Programs | Accessories | System Tools | System Information | Tools | Version Conflict Manager.

You'll have a small window that lists every file the VCM "updated" during the installation process. Just click on the files you want returned to their original states, then click on Restore Selected Files, and the chances are very good that you'll be back in business. (John Seymour's Tips are on the znet.com/pcmag/insites/js981030.htm, or goto znet then pcmag/tips).

Format copying.

If there's a format in a document that you'd like to apply in some other part of the document, don't bother with a lot of fancy manipulations. Just click on a line that contains the format you want to use and then click the Format Painter button (it looks like a paint brush) in the toolbar. Move to the text where you want to apply the format and use the mouse to 'paint' over it. Excel or Word will reformat your text.

To copy paragraph formatting in Word, copy the paragraph mark from the end of the paragraph you like, go to the end of the paragraph you want to

change. Make the marks visible by clicking the Show/Hide Nonprinting Characters button (it looks like a ¶) or press Ctrl-Shift-8 Show/Hide toggle. Then select the paragraph mark (another ¶) at the end of the paragraph whose formatting you want to copy, Edit-Copy, select the paragraph mark at the end of the target paragraph and Edit-Paste.

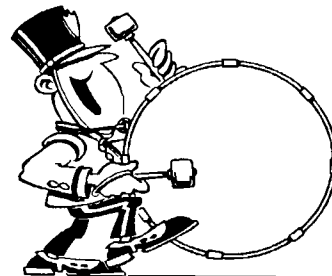
